

## *President's Message*

Over the years that I've been involved with the League, we've addressed many issues. It's been everything from prison reform to agriculture to education to regional transit. While all of those were important issues to address, I've been pleased to see that for the last several years the League at all levels has focused on voting rights, redistricting, and campaign finance reform.

In 2012 the State League formed a committee to revise its existing redistricting position. At the time, the position was little more than stating that the process should be transparent and open to the public. I served on that committee and learned a lot about how other states handle redistricting. After our group studied the issue extensively and developed questions to go to the local Leagues, those Leagues took action. They conducted their own review of the subject, submitted their responses, and a consensus was reached. The State position now supports an independent commission for the state's redistricting. What does that mean? It means that the commission is independent of the state legislature. It will not be the elected officials who decide where the district lines are drawn.

That brings us to 2018. The State League has filed a lawsuit against the state for the redistricting that occurred in 2012. A number of League members, including me, are plaintiffs in that lawsuit. It's a slow process, but it will be an interesting path to follow.

For the November election, the League is supporting two ballot proposals related to our mission. Proposal 2 is the Voters Not Politicians redistricting plan. Proposal 3 is Promote the Vote, a comprehensive voting rights bill that was started by a group including the League. Some of you gathered signatures for one or both of these ballot proposals, so you are already invested in these proposals passing.

There are a number of upcoming events mentioned elsewhere in this newsletter, including candidate forums and the October 22 Center for Michigan Town Hall meeting. The next general meeting will be on October 6, and I'm planning to bring a supply of VOTE bookmarks. We recently got a call from a lady who received one of the bookmarks at an event. She was so impressed by it, she asked for a supply to pass out. Even though she lives in Oakland County, we agreed to give them to her.

We have a great opportunity to get our name out there to family, friends, co-workers, neighbors, and strangers about the ballot proposals and about using Vote411.org for candidate information. If you can't make it to any of the upcoming events, including the general meeting, let me know if you'd like some bookmarks. We have a lot invested in this election, and the more we spread the word, the better chance there is that the ballot proposals will pass.

I hope to see you soon. As always, thank you for supporting the League.

## *WOMEN'S EQUALITY DAY 2018*

The Women's Equality Day Luncheon was on August 25<sup>th</sup> in Livonia. The NW Wayne County League was well represented, with over a dozen in attendance. Our own Laura Callow presented a history of the Equal Rights Amendment (ERA). Only 35 states of the necessary 38 had ratified the amendment by the 1982 deadline. In 2011, legislation was introduced to speed ratification of the ERA, and to remove the deadline. Spurred by the resurgent interest, Nevada ratified the ERA in

2017, followed by Illinois in May, 2018. Only one more state to go!

To remove the deadline for ratification of the ERA, call Senate Judiciary Chair, Chuck Grassley to demand a hearing on S.J. Res. 5 and House Judiciary Subcommittee Chair, Steve King to demand a hearing on HJ Res. 53. It is the fervent hope of all ERA supporters we can soon celebrate this long-awaited constitutional amendment.

Lisa Brown, Oakland County Commissioner and former member of the Michigan House of Representatives, was the keynote speaker. She discussed the need for more women in politics to over-ride prejudices about women's issues and their role in government, stressing equality.
